Mrs. SHAHEEN (for herself and Mr. KENNEDY) introduced the following bill;
which was read twice and referred to the Committee on Small Business
and Entrepreneurship

A BILL

To amend the Small Business Act to enhance the Office
of Rural Affairs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Coordinated Support
5 for Rural Small Businesses Act”.

6 **SEC. 2. OFFICE OF RURAL AFFAIRS OF THE SMALL BUSI-**
7 **NESS ADMINISTRATION.**

8 Section 26 of the Small Business Act (15 U.S.C. 653)
9 is amended—

1 (1) in subsection (a), by inserting “ESTABLISH-
2 MENT.—” before “There”;

3 (2) by amending subsection (b) to read as fol-
4 lows:

5 “(b) APPOINTMENT OF ASSISTANT ADMINIS-
6 TRATOR.—

7 “(1) IN GENERAL.—The Office shall be admin-
8 istered by an Assistant Administrator, who shall—

9 “(A) be appointed by the Administrator;
10 and

11 “(B) serve as a noncareer appointee, as de-
12 fined in section 3132(a)(7) of title 5, United
13 States Code.

14 “(2) QUALIFICATION.—The position of Assist-
15 ant Administrator shall be a Senior Executive Serv-
16 ice position under section 3132(a)(2) of title 5,
17 United States Code.”;

18 (3) in subsection (c)—

19 (A) in the matter preceding paragraph (1),
20 by inserting “DUTIES.—” before “The Office”;

21 (B) in paragraph (1), by striking “small
22 business concerns located in rural areas” and
23 inserting “rural small business concerns”;

24 (C) in paragraph (3), by striking “con-
25 cerning the” and all that follows through the

1 semicolon at the end and inserting the fol-
 2 lowing: “on the policies and programs of the
 3 Administration and of other Federal depart-
 4 ments and agencies for assisting rural small
 5 business concerns;”;

6 (D) in paragraph (4), by striking “; and”
 7 and inserting a semicolon;

8 (E) in paragraph (5)—

9 (i) by striking “the United States
 10 Tourism and Travel Administration” and
 11 inserting “the National Travel and Tour-
 12 ism Office of the Department of Com-
 13 merce”;

14 (ii) by striking “small businesses in
 15 rural areas” and inserting “rural small
 16 business concerns”; and

17 (iii) by striking the period at the end
 18 and inserting “; and”; and

19 (F) by adding at the end the following:

20 “(6) host outreach events for rural small busi-
 21 ness concerns as described in subsection (d).”; and

22 (4) by adding at the end the following:

23 “(d) OUTREACH.—The Assistant Administrator
 24 shall—

1 “(1) host outreach events in various regions of
2 the United States for rural small business concerns;
3 and

4 “(2) invite representatives from district offices
5 of the Administration, resource partners, Federal
6 and State agencies, and other interested persons to
7 participate in such outreach events.

8 “(e) INTERAGENCY COOPERATION.—The Assistant
9 Administrator shall coordinate with the Department to—

10 “(1) conduct outreach regarding programs of
11 the Administration and the Department and to im-
12 prove awareness and utilization of the existing pro-
13 grams and services of each agency; and

14 “(2) convene interagency working groups to ad-
15 dress issues including—

16 “(A) capital access and investment in rural
17 areas of the United States, which may in-
18 clude—

19 “(i) identifying areas of overlap be-
20 tween the business loan programs of the
21 Administration and the Department of Ag-
22 riculture, including where intermediaries
23 may be able to participate in programs at
24 both agencies;

1 “(ii) assessing opportunities for co-
2 ordination between the Administration and
3 the Department on programs for rural
4 communities of each agency through the
5 district offices of the Administration, rela-
6 tionships with rural lenders, resource part-
7 ners of the Administration, and joint out-
8 reach and marketing efforts;

9 “(iii) improving information sharing
10 and discussion of best practices between
11 the Administration and the Department;

12 “(iv) examining coordination between
13 the small business investment company
14 program under part A of title III of the
15 Small Business Investment Act of 1958
16 (15 U.S.C. 681 et seq.) and related pro-
17 grams at the Department, including the
18 Rural Business Investment Program of the
19 Department;

20 “(v) examining opportunities for co-
21 ordination between the disaster assistance
22 programs of the Administration and the
23 Department; and

24 “(vi) addressing barriers and exam-
25 ining opportunities for cooperatives to par-

1 ticipate in programs and access resources
2 of the Administration that are similar to
3 the financing programs of the Department
4 that serve cooperatives; and

5 “(B) assisting rural small business con-
6 cerns, which may include—

7 “(i) identifying overlap and frag-
8 mentation among the rural markets identi-
9 fied by the Department and rural census
10 tracts identified by the Administration;

11 “(ii) exploring opportunities to sup-
12 port innovation in rural areas;

13 “(iii) coordinating effective support
14 initiatives that benefit Native Americans;
15 and

16 “(iv) collaborating on technical assist-
17 ance, especially with respect to exportation
18 and procurement.

19 “(f) UPDATES.—Not later than 7 days after any
20 change to or new issuance of a memorandum of under-
21 standing between the Administration and the Department,
22 the Administration shall notify the appropriate congres-
23 sional committees.

24 “(g) REPORT.—

1 “(1) IN GENERAL.—Not later than 180 days
2 after the date of the enactment of this subsection,
3 and annually thereafter, the Administrator shall sub-
4 mit to the appropriate congressional committees and
5 make publicly available on a website of the Adminis-
6 tration a report on the activities of the Office during
7 the 1-year period immediately preceding the date of
8 submission of the report.

9 “(2) CONTENTS.—Each report required under
10 paragraph (1) shall include the following:

11 “(A) The operational details of the Office,
12 including the name of the Assistant Adminis-
13 trator, the budget of the Office, and the num-
14 ber of full-time employees employed by or de-
15 tailed to the Office.

16 “(B) A summary of the activities con-
17 ducted under subsection (c).

18 “(C) The number of outreach events con-
19 ducted by the Administration to promote poli-
20 cies and programs described in paragraph (3)
21 of subsection (c) and to provide information de-
22 scribed in paragraph (4) of such subsection.

23 “(D) An analysis of the lending programs
24 of the Administration in serving the needs of
25 rural small business concerns.

1 “(E) A summary of activities conducted
2 under subsection (e), including—

3 “(i) the status of any memorandum of
4 understanding between the Administration
5 and the Department of Agriculture to fur-
6 ther the goals of improving service deliv-
7 ery, advice, and assistance for rural small
8 business concerns;

9 “(ii) a summary of outreach efforts
10 under subsection (e)(1);

11 “(iii) a summary of working groups
12 created under subsection (e)(2), including
13 any areas of overlap identified in capital
14 access programs under subparagraph (A)
15 of such subsection; and

16 “(iv) efforts to assist rural small busi-
17 ness concerns under subsection (e)(2)(B).

18 “(h) DEFINITIONS.—In this section:

19 “(1) APPROPRIATE CONGRESSIONAL COMMIT-
20 TEES.—The term ‘appropriate congressional com-
21 mittees’ means—

22 “(A) the Committees on Small Business
23 and Entrepreneurship and the Committee on
24 Agriculture, Nutrition, and Forestry of the Sen-
25 ate; and

1 “(B) the Committee on Small Business
2 and the Committee on Agriculture of the House
3 of Representatives.

4 “(2) ASSISTANT ADMINISTRATOR.—The term
5 ‘Assistant Administrator’ means the Assistant Ad-
6 ministrator of the Office of Rural Affairs appointed
7 under subsection (b).

8 “(3) DEPARTMENT.—The term ‘Department’
9 means the Department of Agriculture.”.
