To amend the Federal Crop Insurance Act to provide premium support for certain plans of insurance, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Federal Agriculture
- 5 Risk Management Enhancement and Resilience Act of
- 6 2025" or the "FARMER Act of 2025".
- 7 SEC. 2. PREMIUM SUPPORT FOR CERTAIN PLANS OF IN-
- 8 SURANCE.
- 9 Section 508(e) of the Federal Crop Insurance Act of
- 10 1938 (7 U.S.C. 1508(e)) is amended—

3	(2) in paragraph (9) (as so redesignated) by
4	striking "and (7)" and inserting "(7), and (8)"; and

8	of insurance.—Notwithstanding subparagraphs
9	(F) and (G) of paragraph (2), in the case of an indi-

13	whole farm units, the Corporation shall pay a part

5	(b) Premium Subsidy.—Section 508(e)(2)(H)(i) of
6	the Federal Crop Insurance Act (7 U.S.C.
7	1508(e)(2)(H)(i)) is amended by striking "65" and insert-
8	ing "80".
9	SEC. 4. STUDY.
10	Section 522(c) of the Federal Crop Insurance Act (7
11	U.S.C. 1522(c)) is amended by adding at the end the fol-
12	lowing:
13	"(20) Study on supplemental coverage
14	OPTION.—
15	"(A) In General.—The Corporation shall
16	carry out a study, or offer to enter into 1 or
17	more contracts with 1 or more qualified persons
18	to carry out a study, to determine the feasibility
19	of modifying the supplemental coverage option
20	described in section $508(c)(4)(C)$ to provide
21	coverage for counties larger than 1,400 square
22	miles—
23	"(i) at a level smaller than county-

3	"(B) Report.—Not later than 1 year
4	after the date of enactment of this paragraph,
5	the Corporation shall submit to the Committee
6	on Agriculture, Nutrition, and Forestry of the
7	Senate and the Committee on Agriculture of
8	the House of Representatives a report that de-
9	scribes—
10	"(i) the results of the study carried
11	out under subparagraph (A); and
12	"(ii) any recommendations with re-
13	spect to those results.".
