 - 8 (a) Definitions.—In this section:

1	(1) Civil service.—The term "civil service"
2	has the meaning given the term in section 2101 of
3	title 5, United States Code.
4	(2) Contract employee.—The term "con-
5	tract employee" means—
6	(A) an employee of a contractor; or
7	(B) in the case of a contractor who is an
8	individual who directly enters into a contract
9	with the Federal Government, that individual.
10	(3) CONTRACTOR.—The term "contractor" has
11	the meaning given the term in section 7101 of title
12	41, United States Code.
13	(4) Director.—The term "Director" means
14	the Director of the Office of Personnel Management.
15	(b) Website.—Not later than 18 months after the
16	date of enactment of this Act, the Director shall establish,

8	(c) Annual Report.—
9	(1) In general.—Not later than 1 year after
10	the date of enactment of this Act, and annually
11	thereafter, the Director shall make publicly available
12	a report that details, for the year covered by the re-

14	(A) the total number of contract employees
15	that worked, on a part-time or full-time basis
16	under applicable contracts with the Federa

18	(B) the total cost incurred by the Federa
19	Government with respect to the work described
